On November 21, 2014, Mondelēz International, Inc. increased the size of our Board of Directors (the "Board") from 12 to 13 members and appointed Joseph Neubauer to the Board effective as of the close of business on November 21, 2014. The Board has not yet determined to which committees it will appoint Mr. Neubauer.

Mr. Neubauer will receive the same compensation and indemnification as our other non-employee directors. The compensation program is described in our Proxy Statement on Schedule 14A filed with the U.S. Securities and Exchange Commission (the "SEC") on April 1, 2014. The form of indemnification agreement is an exhibit to our Annual Report on Form 10-K filed with the SEC on March 3, 2014.

There are no transactions between Mr. Neubauer and us that would be reportable under Item 404(a) of Regulation S-K.

DEERFIELD, Ill. – Nov. 24, 2014 – Mondelēz International announced today that it will add Joseph Neubauer to its Board of Directors. Neubauer, 73, is Chairman of the Board at Aramark, a leading global provider of professional services.
