Explanation of Responses:

- Withholding of shares of common stock to satisfy tax withholding obligations in connection with the vesting of restricted stock under the Issuer's Amended and Restated 2005 Performance Incentive Plan and Mr. Brearton's retirement agreement.
- Since the date of Mr. Brearton's last ownership report, he transferred 43,181 shares of Mondelez International common stock from a directly owned account to a revocable trust account.
- Effective December 31, 2015, Mr. Brearton retired from Mondelez International, Inc. Pursuant to the terms of the issuer's Amended and Restated 2005 Performance Incentive Plan and Mr. Brearton's retirement agreement, certain unvested restricted shares were forfeited upon his retirement.
- Shares represent interests in the Mondelez International Stock Fund, which are payable in cash. The Reporting Person's interests in the Mondelez International Stock Fund fluctuate with the fund's performance. The information in this report is based on a plan statement for the period ending December 31, 2015.
